Session 1 – 14:00 to 14:50 – Interpreting the Short Term Study rules

In this session we will look at the rules relating to the short term study route as well as looking at some specific issues for example:

- Non-visa national students getting new visa stamps when they re-enter the UK following a short holiday
- Students who are incorrectly given a visit visa stamp instead of the short term study stamp
- What advice (information) can schools give to their prospective students in relation to making a visa application
- Common pitfalls and Risk management how to ensure that both schools and students remain compliant.
