Hungarian Language Learning Programme



Background



Tempus Public Foundation (TPF)

- the National Agency for Erasmus and other mobility programmes,
- operates under the supervision of the Ministry of Human Capacities in Hungary,
- has been appointed by the Hungarian Government to implement a language learning scholarship programme.







Hungarian secondary school students

- grades 9 (age: 15-16)
- grade 11 (age: 17-18-19)
- a two-week English language summer course during their holidays in the United Kingdom, Ireland or Malta
- full financial support of the Hungarian Government





Application:



- groups can apply for 30 days (mid February-mid March)
- individuals can apply for 60 days (mid February- mid April)

Financial condition:

- beneficiaries request TPF to pay on their behalf directly to the language centre
- invoice is issued to the students/ beneficieries

LC will contact the students/MPOC directly to arrange enrolment, transfer, invitation letter

TPF migrates language centre information, course and associated services information to the SMP	January –February 2020
TPF provides access to the SMP for language centre contacts	January 2020
TPF opens the SMP for student applications	February 2020
Eligible applicants may proceed to selecting a course as Beneficiaries	from February 2020
LC monitors beneficiary course requests in SMP – accepts/rejects individual or group requests	
TPF issues the grant certificate to the beneficiary	February-March 2020
LC contacts beneficiary with enrolment form, placement test, details of the course and accommodation, etc.	February-March 2020
TPF transfers due fees to LC on beneficiary's behalf	March-April 2020
LC receives individuals and groups to LC	13 th June-31 st August 2020
LC monitors arrivals, attendance and completion – signals at instances of no-show, termination and completion	13 th June-31 st August 2020
•	last day of language course / 13 th June-31 st August 2020
LC confirms issue of certificate and attendance in SMP	last day of language course / 13th June-31st August 2020
