Mexico City, February 4th to 8th 2010

Event Summary

- ➤ An Expo offering a B2B element (agent meetings) within a B2C event
- ➤ Morning meetings with agents, afternoon/evening Expo B2C
- ➤ 2 major venues in and around Mexico City
- ➤ Friday 5th February, Hotel Sheraton Suites Santa Fe in the heart of the new business and school district to the west of the city
- ➤ Saturday and Sunday 6th and 7th February, Hotel Sheraton Maria Isabel, Reforma on Mexico City's main Avenue in the centre of town

Background to the Fair

- ➤ Mexico is a largely untapped market for UK English language and residential/high school/UFP providers
- Over recent years there has been a lack of promotion of the UK as a study destination in Mexico
- ➤ This has left the market open for Canada and Australia to exploit regular nationwide fairs are held promoting both countries as a study destination with support from a coordinated network of agents
- ➤ There is no event of this type promoting the UK as a study destination
- The UK is seen as inaccessible, expensive and remote
- ➤ Yet the UK remains the destination of choice for Mexicans who prefer British English and the kudos associated with the UK/Europe
- Mexicans retain the status of non visa nationals for the UK whilst this is not the case with competitor countries; Canada introduced a visa requirement for Mexicans in the summer of 2009
- Mexicana has recently introduced direct flights to the UK from Mexico City with very reasonable return fairs: > USD 900
- ➤ The situation demands an enhanced presence and promotion of the UK as a viable and accessible study destination
- ➤ As a pilot event the Expo will focus on Mexico City and will be pitched at a mainly younger audience summer schools, study abroad, etc.
- ➤ At the Sao Paulo fair recently, providers where canvassed as to their interest in such an event, with positive feedback

Event Details

- ➤ Opportunity for min 10, max 30 English UK members
- ➤ Anglo Latino Education Partnership to make all arrangements in country:
 - o Liaison with event locations and reservation of venues including hotel rooms for participants
 - Event promotion: press advertising, email shots, contact with local schools and universities, contact agents inviting them to participate in the fair
 - Extend invitation to potential participants
 - Seek the collaboration and support of English UK, English UK
 North, British Embassy, British Council, UKTI
 - o Coordinate the shipping of materials for the fair
 - Manage the event and coordinate follow up, registering participants and providing information and support in country post event
- ➤ Confirmation of participation in event required by 16th December

Cost per participating school

- Expo Cost 3 days: <u>GBP 750</u>; 2 days: <u>GBP 575</u>
 - O Includes: agent meetings, B2C Expo, refreshments, transfer between venues, event promotion, organization, local taxes
- Translator/interpreter per Expo GBP 50
 - O Anglo Latino to make all payment arrangements in country
- Accommodation at Sheraton Maria Isabel / room /night USD 115 + Tax (payable directly to the hotel) group rate min 10 participants
- Reservation deposit of GBP 300 required from each participant by deadline above deposit required to reserve Expo rooms
